## **TAP FEES**

¾" Tap - \$2,500.00 plus the costs of parts and installation.

1" Tap - \$5,000.00 plus the costs of parts and installation.

All other tap sizes must be reviewed and approved by the Board of Directors.

\*A payment plan is available. Please contact the Association office for details regarding a payment plan.

## **APPLICATION PROCESS**

1. The Application must be completed and turned into the Association office. The application will then be presented to the Board of Directors who will determine whether said application can be approved. Approval expires 12 months from the date May Valley Water Association signs the application.
2. Once the Application is approved, payment arrangements must be made with the Association prior to installation. Please contact the Association at least two weeks prior to wanting the tap installed.
3. If a permit is required to install your tap, the fee will need to be paid prior to installation.
4. Once the tap fee is paid, you will be issued a membership certificate.
5. Once the tap is installed, you will receive a statement from the Association for the materials that were used for installation. The costs of excavation will be billed to you separately by the company that performs the excavation.
6. If you fail to use water which you are entitled to by not installing the tap, you will pay the minimum charge for use beginning the first day of the 13<sup>th</sup> month after issuance of the certificate of membership.

## **MAIN LINE EXTENSIONS**

If a main line extension is required to install a tap, the following rules will apply, to-wit:

1. You will be responsible for all costs and fees to install the extension.
2. A licensed and bonded contractor must be used for said installation and must be approved by the Association.
3. The contractor must provide the Association with insurance documents naming the Association as additionally insured when working on any main line construction.
4. All mainlines are required to have tracing wires installed. All extensions must pass pressure testing and be disinfected and pass Bac T analysis.
5. Easements and right of way deeds must be supplied before work commences.
6. Customer is responsible for the maintenance and upkeep of line extensions for the first twelve months after installation. After said twelve months has elapsed, ownership of said line extension shall revert to the Association and the Association will then be responsible for the maintenance and upkeep of the same.
7. All main line extensions are to be warranted by the contractor and applicant for no less than 12 months with a 3 month extension if deficiencies occur.

## **OTHER REQUIREMENTS**

1. Cross-connections will not be allowed and are unlawful without following the guidelines set forth by the Colorado Primary Drinking Water Regulations.
2. Each membership in this Association is entitled to one service connection.
3. Do not plant trees, shrubbery, etc. within five feet of the meter pit.
